HANDLING PRECAUTIONS
STORAGE
Store in original container tightly closed and in a locked, dry, cool area, away from foodstuffs. Store in accordance with NZS 8409 Management of Agrichemicals.
Stores containing 100kg of Omite 30W require signage and more than 100kg require emergency response plans.

PERSONAL PROTECTION
Avoid contact with skin and eyes and inhalation of spray mist.
When handling wear eye protection, appropriate respiratory protection, waterproof gloves, overalls and boots. Do not eat, drink or smoke while using.
Remove protective clothing and wash hands and face thoroughly before meals and after work.

EQUIPMENT
Apply using well maintained and accurately calibrated equipment.

DISPOSAL
Triple rinse container and add residue to spray tank. Submit clean empty container for recycling through Agrecovery. If this is not possible bury in landfill.
Dispose of product only by using according to the label or at an appropriate landfill.

FIRST AID: If swallowed do NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If in eyes, wash out immediately with water.

SPILLAGE: Wear appropriate protective clothing and prevent material from entering waterways. Sweep up solids without creating dust. Wash area with water and absorb with inert material. Dispose of waste safely in a suitable landfill.

TRANSPORT: Do not carry Omite 30W on a passenger service vehicle.

RECORD KEEPING: Records of use as described in NZS 8409 Management of Agrichemicals must be kept if 3kg or more of Omite 30W is applied within 24 hours.

COMPATIBILITY: Compatible with a wide range of insecticides and fungicides. Do not mix with oils, or alkaline materials such as Bordeaux mixture or lime sulphur.

DIRECTIONS FOR USE:

Omite 30W is effective throughout the season but has the added advantage of enhanced vapour activity during warm weather. It controls active mite stages but does not control eggs. A spring application should be timed to coincide with the hatching of winter eggs, or first generation summer eggs. In the summer when populations are heavy, and all life stages are present, make two applications 10-14 days apart. Mites are normally controlled in 5 days but under cool conditions 10-20 days may be required for effective control. Concentrate spraying is not recommended. Apply as a dilute spray ensuring complete tree coverage and thorough wetting of both upper and lower sides of the leaves.

Apples	European red mite Two spotted mite	200g/100 litres water	Do not spray in combination with diazinon if temperatures exceed 35°C as leaf and fruit spotting may occur. Do not treat pears or nashi
Stonefruit (apricots, nectarines, peaches, plums)	European red mite Two spotted mite Tydeid mite Peach silver mite	200g/100 litres water	
Berryfruit	Two spotted mite	200g/100 litres water	Strawberries: Do not apply when fruit is present as fruit damage may occur. Do not combine with other chemicals, wetting agents or nutrients or spray if daily temperatures exceed 26°C, as foliage damage may occur. A water rate of at least 1000 litres/ha will reduce the risk of foliage damage.
Grapes	European red mite Two spotted mite	200g/100 litres water (6kg/ha)	Treat before populations become heavy. Use equipment designed to penetrate the vines.
Citrus	Citrus red mite	200g/100 litres water	Do not apply within 6 weeks of any oil spray. Omite 30W may cause some leaf burn on new growth of lemons.
Hops	Two spotted mite	200g/100 litres in 2000 litres water per hectare (4kg/ha)	For maximum early season control apply Omite 30W pre-burr formation in tank mix with Apollo®50SC. If mites become a problem later in the season a second application of Omite 30W may be applied. Alternatively, apply two Omite 30W applications 14 days apart as required. Complete coverage of vines, especially the tops, is essential. Do not apply when air temperatures exceed 30°C. Do not apply to vines under moisture stress. Do not apply with surfactants, insecticides or foliar fertilisers unless such mixtures have been proven safe to the crop.
